### DIRECTIONS FOR USE:

Read entire label and use accordingly.

**General Use Instructions:** SHAKE WELL BEFORE USING. To spray, hold container upright and point valve opening to targeted area.

**If surface compatibility is unknown, treat a small area of surface to be sprayed and evaluate 30 minutes later to allow any potential staining to occur.**

**Bed Bugs:** Apply around baseboards, floorboards, floor molding, bed frames, wall hangings, mirrors, pictures, headboards, box springs, mattresses, electrical switch plates, furniture, door frames, bookcases, window frames or other places where bed bugs are found or known to harborage. When treating luggage, furniture and mattresses, pay special attention to tufts, folds, seams or hard to access areas.

**Crawling Insects:** Spray places where insects may hide, such as cracks, crevices, and void areas, around baseboards, floorboards, around pipes and appliances.

**Ants:** Spray trails, mounds/nests, cracks and crevices around windows, doors, sills and other openings where ants may be entering.

**Fleas:** Spray floors, floor coverings and pet quarters. Do not spray directly on pets.

**Spiders:** Spray webs and places where spiders nest. Spray directly on spiders where possible.

**Flying Insects:** Contact flying insects directly. Spray with sweeping motion.

**Termites:** Kills termites on contact. Spray where termites are seen.

**Food handling establishments:** When using in food areas of food handling establishments, foods should be removed or covered. Do not apply directly to food contact surfaces.
